

**SOUTH OXFORDSHIRE DISTRICT COUNCIL**  
**ERRATUM TO THE REGULATION 22 CONSULTATION STATEMENT**  
**May 2019**

- 1.1. Since the Submission of the South Oxfordshire Local Plan 2034, the Council has identified that the Regulation 22 Consultation Statement (**CSD11**) does not specifically reference three petitions submitted as representations during the Regulation 19 publicity period.
- 1.2. The petitions received during the Regulation 19 publicity period were as follows:
  - Cuddesdon and Denton Parish Council – 1 signatory
  - Culham Parish Council – 13 signatories
  - Hazel Douglas – 132 signatories
- 1.3. The Council has treated these petitions as representations and has incorporated them into their analysis and identification of key issues raised by respondents but wishes to include reference to them here for clarification. A summary of the issues raised by the petitions is available to view in Appendix 3 to the Regulation 22 Statement (**CSD11.1**) under the above names and as full representations on the Council's Examination Library.
- 1.4. In addition, the Council has been notified by a small number of respondents who consider that their original representations have not been accurately reflected by the summaries in Appendix 3 to the Regulation 22 Statement (**CSD11.1**). Whilst the comments identified have been taken into account and the Inspector has receipt of all the Regulation 19 responses in full, this erratum corrects these by reference to Appendix 1 attached (changes itemised in yellow).
- 1.5. All representations and petitions received from the publicity period on the Publication Version of the Local Plan 2034 have been sent to the Planning Inspectors in their entirety alongside the Submission Version of the plan and are also available to view and access on the Council's Examination Library<sup>1</sup>.
