INTRODUCTION

The purpose of this document

- 1. This document provides a record of the publication that took place on the Dorchester-on-Thames Neighbourhood Plan Area Publication. The main publication methods used to promote the publication, along with the main findings from the publication are also documented. This publication process is not expected to return a high consultation response rate, as it is merely looking at the suitability of the neighbourhood plan area. A higher response rate is expected with consultation on the main neighbourhood plan.
- 2. This publication allows us to consult with affected bodies regarding the suitability of the proposed neighbourhood planning area. This process must take place before the district council as the local planning authority can ratify the neighbourhood planning area for a settlement.
- This document builds upon the previous consultation plan that was prepared for this stage. The consultation plan set out how we intended to consult on the neighbourhood plan area application.
- 4. A neighbourhood development plan is a way that a local community can come together and plan effectively for their local area. It provides real planning powers to local communities, allowing them to develop and shape their local area, using planning powers. Once passed through a successful referendum (a count of 50% or more), the document carries planning weight.

REGULATIONS AND GOVERNMENT GUIDANCE

- 5. The regulations for this process provide clarity on what must be provided in order to make this a legally compliant publication process. As the local planning authority we must publicise on our website and in manner that brings the information to the attention of those that live, work or carry out business in the effected area, the following:
 - A copy of the area application (essentially a statement and a map of the proposed neighbourhood plan area)
 - Details of how to make representations; and ensure

- The deadline for the receipt of those responses and representations is not less than six weeks following the date on when the application is first publicised¹.
- 6. A full copy of the area application submitted by Dorchester-on-Thames Parish Council is available to view in appendix one.
- 7. There are a number of different guidance documents that the government has produced in order to assist local communities producing a neighbourhood plan. The council has also produced a guidance document to help local communities navigate their way through the suite of documents that are available under the neighbourhood planning and community led planning process. PREVIOUS AND CURRENT CONSULTATION

Previous consultation stages

8. This matter has not been the subject of previous consultation. The parish council are at the earliest stages of their neighbourhood plan development process.

Current publication period

9. The publication period for this stage of the neighbourhood development plan process must cover a minimum period of six weeks². The publication period ran from the 20 February to the 3 April 2013. This met the six week publication period required. The publication period was officially triggered by a formal press notice submitted in the Oxford Herald Series. A copy of this press notice is available to view in appendix two.

The proposed publication period is broken down as follows:

Publication period 20 February to 3 April 2013 Processing of responses 8 April to 29 April 2013

This consultation does run over the Easter holiday period. However, we have not chosen to extend the consultation period, as our production schedules have not allowed this³. Although there has been no previous consultation on this subject, the parish council has been active in promoting the neighbourhood planning process locally. We therefore feel that a six week consultation period will be sufficient.

Publication activities

10. We have used the following publication activities, as we feel that they are suitable for this exercise. We liaised with the clerk for Dorchester-on-Thames, when designing these proposals. The local knowledge of the clerk/neighbourhood planning group was important in ensuring that this publication process utilises the most appropriate mechanisms with the limited resources available to us. This approach has also allowed us to make use of any local contacts or groups/networks that they have identified. The identified methods take into account recommendations from our Statement of Community Involvement and minimum standards set out by regulations. The method of promotion used along with any additional information is displayed in the following table. The shaded areas are what could be considered as regulatory minimums and the none-shaded areas are those considered over and above this approach.

Key issues generated

12. The Environment Agency requested that they are kept involved with the development of the neighbourhood plan, as there are some potential significant flood risks and ecological constraints associated with the neighbourhood plan area. Both Natural England and English Heritage identified supporting material to assist with the development of a neighbourhood plan. A summary schedule of the consultation responses received is available to view in appendix three.

Outcomes

13. The results of this publication will be used by the council to decide whether or not to approve the Dorchester-on-Thames Neighbourhood Planning Area and Dorchester-on-Thames as the relevant neighbourhood planning body. The decision will be taken through delegated powers by the Head of Service for planning.


