SYDENHAM NEIGHBOURHOOD DEVELOPMENT PLAN: MODIFICATION STATEMENT

DATE OF PUBLICATION – 11 November 2021

1. Modification Statement

- 1.1 Regulation 30 of the Neighbourhood Planning (General) Regulations 2012 (as amended) (“the Regulations”) allows the Council to modify a neighbourhood development plan to correct errors with the permission of the Qualifying Body.
- 1.2 The Council brought the Sydenham Neighbourhood Plan into legal force under Section 38A(4) of the Planning and Compulsory Purchase Act 2004 (as amended) on 20 May 2021; and Delegated to the Head of Planning, in consultation with the appropriate Cabinet Member and in agreement with the Qualifying Body, the correction of any spelling, grammatical, typographical or factual errors together with any improvements from a presentational perspective.
- 1.3 The Qualifying Body – Sydenham Parish Council - asked the Council to make the following modifications:

Page 21 –	Add ' The South Oxfordshire Local Plan 2035 was adopted in December 2020. The adopted South Oxfordshire Local Plan 2035 incorporates all the Main Modifications set out in the Inspector’s Report, as well as additional Minor Modifications agreed by the Council. The adopted South Oxfordshire Local Plan 2035 replaces the South Oxfordshire Core Strategy 2012 and saved policies from the South Oxfordshire Local Plan 2011. 3.13 The adopted Local Plan 2035 Appendix 7 has the same settlement hierarchy status for Sydenham West and Sydenham East as the South Oxfordshire Core Strategy 2012. Sydenham West and Sydenham East continue to be classified as “smaller” and “other” villages respectively.	Factual correction.

3.14 The adopted Local Plan 2035 policy H8 states relative to “smaller” villages “ level of growth they are planning for is commensurate to the scale and character of their village, and this is expected to be around a 5% to 10% increase in dwellings above the number of dwellings in the village in the 2011 census (minus any completions since 1 April 2011)”

And for “other” villages the Local Plan 2035 states:

“It is not generally expected that those settlements will provide a significant source of housing supply, However, it is possible that some development proposals may come forward over the plan period in these villages, such as single dwellings, infilling and conversions from other uses.”

3.15 The settlement backland and infill development Policy H16 states that:

“Within Smaller Villages and Other Villages, development should be limited to infill and the redevelopment of previously developed land or buildings.”

“Infill development is defined as the filling of a small gap in an otherwise continuous built-up frontage or on other sites within settlements where the site is closely surrounded by buildings. The scale of infill should be appropriate to its location.”

	“Where a proposal encompasses residential development of land behind an existing frontage or placing of further dwelling/s behind existing dwelling/s within the existing site, the proposals should demonstrate that: i) the privacy of existing and future residents will be protected; ii) means of access can be appropriately secured; and iii) development would not extend the built limits of the settlement”.’	
Page 27- para 5.1	Replace ‘2033’ with ‘2034’	Factual correction.
Page 29 – para 5.7	Remove the word ‘and’ before the word ‘status’. Add new sentence to the end of the paragraph ‘Sydenham West and Sydenham East continue to be classified as “smaller” and “other” villages respectively.’	Factual corrections.
