# CHOLSEY PARISH NEIGHBOURHOOD DEVELOPMENT PLAN: MODIFICATION STATEMENT

#### DATE OF PUBLICATION – 26 October 2022

## 1. Modification Statement

- 1.1 Regulation 30 of the Neighbourhood Planning (General) Regulations 2012 (as amended) ("the Regulations") allows the Council to modify a neighbourhood development plan to correct errors with the permission of the Qualifying Body.
- 1.2 The Council brought the Cholsey Parish Neighbourhood Plan into legal force with the modifications recommended by the examiner on 13 October 2022; and Delegated to the Head of Policy and Programmes, in consultation with the appropriate Cabinet Member and in agreement with the Qualifying Body, the correction of any spelling, grammatical, typographical or factual errors together with any improvements from a presentational perspective.
- 1.3 The Qualifying Body Cholsey Parish Council asked the Council to make the following modifications:

Paragraph 12	Delete 'Following the plan's submission to SODC the revised CNP will be examined by an Independent Examiner who will assess whether the CNP meets the Basic Conditions and whether a further referendum is necessary.' and replace with 'Following the plan's submission to SODC, the revised CNP was examined by an Independent Examiner who assessed whether the CNP meets the Basic Conditions and whether a further referendum is necessary. The examiner found that the revised plan included material modifications which did not change the nature of the plan, and which required examination but not a referendum. The examiner also found that the CNP meets the basic conditions for the preparation of a neighbourhood plan subject to a limited number of recommended modifications.'	Factual correction.
