### INTRODUCTION AND RATIONALE

Benson is currently preparing a Neighbourhood Plan. As part of its evidence gathering process, the Neighbourhood Plan Steering Group commissioned Community First Oxfordshire (CFO) to conduct a community questionnaire survey in May 2016. CFO is a charity that works with and supports communities across the county and has long-standing expertise in helping communities with consultation strategies.

The survey gave all households in the parish the opportunity to express an opinion on various issues (including parking, traffic, infrastructure and housing development) and to register their own housing need, should they have one.

The survey had six sections.

All households were asked to complete Part 1: Your household; Part 2- Housing Development; Part 3- Transport, Traffic and Road Safety; Part 4- Community Facilities and Infrastructure; and Part 5- Green Space and the Natural Environment.

Part 6 asked households living in Benson which need a different home in the parish to state their requirements.

### **DISTRIBUTION AND RESPONSE**

- CFO, liaising with Benson Neighbourhood Plan Steering Group (NPSG), prepared the survey content.
- The NPSG arranged distribution of surveys to 1400 households in May 2016.
- 595 questionnaires were returned directly to CFO by respondents via pre-paid *Freepost* envelopes: a response rate of 42.4%.
- CFO analysed the returned surveys and prepared this report.
- No information is known about the non-respondents, and no assumptions have been made about their opinions.

#### IMPORTANT NOTE: THE BREAKDOWN IS INDICATIVE

Not all households are on the Housing Register. A household's needs would require full analysis of its circumstances through a Housing Register application. There are restrictions on the number of bedrooms that someone is considered eligible for, depending on the make-up of the household and whether the home is rented or purchased on a shared ownership basis. In addition, there may be additional Benson households already on the housing register which did not respond to this survey.

#### What is affordable housing?

Social rented and shared ownership are examples of types of affordable housing.

#### How does the District Council allocate affordable housing?

The allocation of homes is made by South Oxfordshire District Council and subject to an assessment of a household's needs. A household must be on the SODC Housing Register to be eligible for these homes

#### 13.3 New Build Developments and "Strong" Local Connection

The councils will endeavour to use the flexibilities introduced by the Localism Act 2012 to enable local people to access developments in their parish whilst still giving due weight to the requirement to allocate housing in accordance with the reasonable preference categories.

To facilitate this, the council will adopt a target that aims to ensure that 20% of new build lettings, that are not rural exception sites or developed for a particular client group, are offered in the first instance to people with a strong local connection to that parish and who have a housing need as defined by the Allocations Policy (i.e. they are on the active Register).

Some schemes have distinct agreements setting out what the local connection requirements are for that scheme. These rules are often written into the Section 106 agreement. For schemes that do not have a separate agreement, the definition contained in section 13.3.1 will be used to determine local connection for these schemes.

# 13.3.1 Definition of Strong Local Connection for Purposes of Determining Priority for New Build Schemes

For these purposes, a strong local connection is:

- where the applicant(s) have lived in the parish for five years out of the last 8 and are currently resident there.

- where the applicant(s) had previously lived in the parish for at least 5 years and their parents or children still live there and have done for at least 10 years.






1. How many people of each age and gender live in your household?




#### 3. How long have you lived in Benson?




#### 5. What type of accommodation do you live in?


#### 6. What type of property is your home?


#### 7. How many bedrooms does your home have?




#### 8. Does your current accommodation meet your needs?






10. What would be your preference for meeting your housing need? *360 respondents – 406 total choices* 




11. How many vehicles do you have in your household? 570 respondents – 646 total choices






#### 12. Where do you park your main vehicle when at home?



#### 13. If you do not park your vehicle in your garage, what do you use it for? 422 respondents – 478 total choices









#### 14. Which areas from BEN1 to BEN8 do you think are most suitable for future development? 556 respondents – 1514 total choices

# 15. If planning permission is given for housing development in Benson, which option do you think is most suitable? 540 respondents




#### 16. What type of accommodation do you think is needed in Benson? 557 respondents – 2558 total choices




#### 17. Do you think that there is a need for more private rental properties?


#### 18. Do you think that there is a need for more social rented properties?






19. Do you think that priority allocation of affordable housing should be given to those who<br/>live in Benson and/or relatives wishing to live in Benson?567 respondents




20. Do you think that affordable housing should be held in perpetuity for local people? 554 respondents





23. Policy for infill development has so far required respect for the existing characteristics of nearby buildings – what do you think about this policy? 552 respondents











31. Is anyone in your household likely to register for a self-build or custom-built property in the next 5 years? 560 respondents








#### 33. Do you have any difficulties with parking in Benson?






#### 37. If 'yes' to Question 36, how far do you commute? 306 respondents – 550 total choices






38. If 'yes' to Question 36, what transport do you use to commute?

#### 39. If 'yes' to Question 36, by which route do you usually leave Benson?








46. Is your whole household intending to move within Benson in the next five years? 536 respondents




47. Do any members of your household wish or intend to move to their own home in Benson in the next five years? 504 respondents


















