

## **Didcot Central Corridor public consultation survey**

The Didcot Central Corridor project aims to make the town a better place for residents and visitors by improving travel and public space along three important routes – known as the 'Gateway Spine', 'Cultural Spine and Foxhall Road', and the Town Centre.

The project is part of the Didcot Garden Town delivery plan which will help to improve the lives of residents by focussing on helping support shops, encouraging healthy lifestyles and helping to tackle climate change.

Council officers working on this scheme have developed ideas for the three routes, focussing on five geographical areas:

- A4130 and B4493 Science Bridge to Didcot Station
- Didcot Road, Wantage Road and Foxhall roundabout
- Broadway
- Town and station connections
- Cow Lane, Jubilee Way roundabout and Hadden Hill

The consultation involves a survey, which can be completed below, and two drop-in events where you will be able to see the proposals in person and/or speak to the project team and an online interactive map which can be commented on.

# Q3. Do you have any general comments you want to add about the ideas for the A4130 and B4493 – Science Bridge to Didcot Station?

Our Council supports the proposal to improve provision for pedestrians, cyclists and wheelers along the A4130.

The illustrations for the booklet do not identify where the proposed new science bridge will be located, but only make reference to the provision of infrastructure to access it. It would be helpful in future documents if this detail is added, using the location as proposed in the current planning application for the HIF1 package of transport measures (see <a href="https://www.oxfordshire.gov.uk/residents/roads-and-transport/roadworks/future-transport-projects/didcot-and-area-improvements">https://www.oxfordshire.gov.uk/residents/roads-and-transport/roadworks/future-transport-projects/didcot-and-area-improvements</a>). This would provide reassurance to the public that the link from Didcot station to the Science Bridge has been considered.

Our Council supports the need to improve the experience for pedestrians and cyclists along this road, particularly as it is close to two Didcot secondary schools (Aureus and Didcot Girls' School).

As highlighted in the consultation document, there are already cycle and pedestrian ways along Didcot Road and Wantage Road but they require improvement. Providing safe movement for cyclists and pedestrians on the Foxhall roundabout is particularly important as currently it is dominated by car traffic and difficult for pedestrians and cyclists to cross.

#### Q7. Do you have any comments you want to add about the ideas for Broadway?

Our Council supports improvements to the area identified as a 'town square' in central Didcot and in particular the suggested improvements to the public realm and improving the experience of cyclists and pedestrians in this area.

The diagrams in the consultation document are not that clear about what is proposed for this area. The description explains that the main differences between the ideas is that traffic along Broadway will be subject to different restrictions as follows:

Idea 1 – Only buses and emergency vehicles will still be able to drive along the Broadway

Idea 2 – All types of vehicles will be able to drive through the town square, but only at certain times of day

Idea 3 – All vehicles allowed

Ideas 1 and 2 will have significant impact on car journeys within the local area and the County Council should undertake further studies to understand what this impact will be, and whether these options could lead to more car journeys through adjoining residential areas. Also, both the fire station and ambulance station are located on Broadway, has sufficient consideration been given to how these changes will affect the emergency services? Further studies should be undertaken before idea 1 or 2 is progressed.

# Q9. Do you have any comments you want to add about the ideas for Town and station connections?

Our Council strongly supports improvements to the connections between the town and the station.

The way in which these ideas are presented makes it difficult to interpret the consultation document. This could affect how residents respond to the consultation.

For example, considering ideas 1 and 2 for the Town and station connections, it is not clear from the mapping how the two alternatives differ. The description in the booklet highlights a difference between provision of cycle lane on one or both sides of the road. The mapping of cycle provision could be changed to improve legibility. A similar issue occurs on the Jubilee Way ideas maps, where it is unclear if general traffic will still remain and whether the road will still remain two-way.

The key for all Connections Ideas plans doesn't clarify the difference between dashed and solid lines, this should be added. Connections Ideas plan 3 shows the route between the Foxhall Road roundabout and Broadway being suitable for walking and also cycling, however parts of the route are Public Right of Way footpaths with signage highlighting no access for bicycles. Are these to be upgraded to Bridleways? If so, there is a concern

about width constraints for two-way flows of pedestrians and cyclists along this route, particularly between Lydalls Close and Broadway.

The footway between Vauxhall Barracks Walk and Lydalls Road to the east of the footway that runs by the All Saints Church appears to be unmanaged/inaccessible on Google Street View (2015), please ensure the operation / suitability of this route.

Connections Ideas Plans 1-3 show a fork on Hitchcock Way in the proposed provision ahead of joining the Jubilee Way Roundabout, it would be helpful to clarify how this would operate. We understand that the segregated cycleway is proposed to be on the northern side of the carriageway and thus the fork looks to extend into the carriageway.

Lydalls Road is shown on the Connections Ideas plans for walking and cycling purposes, while the cross-section looks to facilitate provision for walking only. Additionally there are sections of Lydalls Road that do not have pavement on both sides of the carriageway (east of Haydon Road). Clarity on how pedestrians will cross the carriageway would be helpful to illustrate, both in practical terms as well as wayfinding terms. Dropped kerbs should also be provided for all accesses, noting that the Lydalls Nursery School does not currently provide these (this must be unhelpful for parents with pupils transported in buggies, as well as the general public).

	Cow Lane is in the same area highlighted immediately above (as
	seen in the other labelled areas), but it is in fact geographically
	separate. Map labelling in future documents should be adjusted
	to help clarify this point, alongside a reordering of the list. It is
	confusing as there is another bridge under the railway next to

Hadden Hill Roundabout. The document also mentioned Northern Perimeter Road 3 but local residents would be unlikely to understand what this project is. There are also no timescales within the document for its delivery.
It is recommended that in line with the suggestions in the consultation document, further testing and analysis is done to work out which option is the right one for Cow Lane, Jubilee Roundabout and Hadden Hill roundabout.
